Receiving Procedures

Every Morse drum handler is inspected prior to shipping. However, damage may be incurred during transit.

- Check for visible damage. If you choose to accept damaged freight, always sign noting the damage on the **BILL OF LADING**.
- Document the damage and have the truck driver sign. We recommend keeping a digital camera at your receiving dock for this purpose.
- Open packages expeditiously to check the condition of the goods. There is only a 24 hour window to notify the carrier of any concealed damage.
- IMMEDIATELY REPORT ALL DAMAGE TO THE SHIPPING COMPANY! Then you may contact Morse for assistance with your freight claim.
- Morse Manufacturing will not be held responsible for any damaged freight that is not signed for as damaged.

Limited 2 Year Warranty

Morse drum handling equipment is guaranteed against defects in workmanship or materials for **TWO YEARS** when used properly within its rated capacity. Warranty does not cover wear from normal use or damage from accident or abuse. Motors and other purchased parts carry the warranties of their manufacturers.

For warranty claims, contact your Morse Dealer to obtain a return authorization number, and for return freight advice. Return freight must be prepaid.

In all instances, liability is limited to the purchase price paid or to repairing or replacing the product. Customer assumes liability for any modifications, unauthorized repairs or parts substitution.



Safety Information

While Morse Manufacturing Co. drum handling equipment is engineered for safety and efficiency, a high degree of responsibility must be placed upon the machine operator to follow safe practices, based primarily on common sense, upon which true safety depends.

Failure to follow the safety precautions in this manual can result in personal injury or property damage. Observe the same precautions as with similar machinery where carelessness in operating or maintenance is hazardous to personnel. Carefully read the safety precautions below and throughout this manual.

Review the Material Safety Data Sheet(s) for the material(s) in the drum(s) and take all necessary precautions. Safety shoes, work gloves, hard hat and other personal protective devices are recommended.

Prior to initial use, inspect all moving parts and test rotation of chain wheel and drum holder assembly. Inspect drum holder assembly for proper operation. Perform necessary load test, inspections, operator training, etc.

Machine Description

Model 186 Adjusto-Karrier is designed to lift, transport and dispense a steel or fiber drum with 15" to 23" (38.1 to 58.4 cm) diameter. Adjusto-Karrier can also be used with metal cylinders within this diameter range.

Do NOT use Adjusto-Karrier with plastic drum.

The maximum full-drum capacity is 500 Lb. (227 kg). Capacity is derated to 250 Lb. (113.5 kg) for a half-full drum. Half-full rating is based on the tilt mechanism's capacity for handling an unbalanced bottom-heavy drum.

Accessories

Kit 1460-P Hand Crank 9" (22.9 cm) Hand Crank.

Replaces standard pull chain to turn drum.



Kit 2690-P Hand Wheel 16" (40.6 cm) diameter Hand Wheel with speed knob.

Replaces standard pull Chain to turn drum.

Important

- 1. Review the Material Safety Data Sheet(s) for the material(s) in the drum(s) and take all necessary precautions. Safety shoes, work gloves, hard hat and other personal protective devices are recommended.
- 2. Please read all instructions thoroughly before attempting to operate your new MORSE drum handler.
- 3. These models have a maximum capacity rating of 500 Lb. (227 kg) full drum and 250 Lb. (114 kg) half-full drum. The 186 is designed to lift, move and pour 15" to 23" (38.1 to 58.4 cm) diameter steel and fiber drums. *DO NOT* exceed these ratings. Exceeding these ratings or handling drums other than those mentioned above is unsafe and could result in equipment damage, excessive wear or awkward handling.
- 4. When loading, unloading, operating, or maintaining your MORSE drum handler, always use care and good judgment. Maintain secure footing and a firm hold. Keep hands and loose clothing away from all moving parts. Never allow anyone to be below any part of a raised drum handler or drum. Read operating instructions and review the pictures in the sales brochure before operation.
- 5. Model 186 is "Group 1 Structural and Mechanical" Below-the-Hook Lifting Device which is covered by the American National Standard ANSI/ASME B30.20. The user should comply with all aspects of this standard.

Assembly Instructions

- 1. Remove chain wheel, chain guide, pull chain and roll pin from carton.
- 2. Place guide over shaft. Align hole in chain wheel with hole in shaft. Hammer roll pin through aligned holes. If roll pin doesn't clear easily, rotate chain wheel 180° and try opposite side.
- 3. Place chain in chain wheel.
- 4. Prior to initial use, inspect all moving parts and test rotation of chain wheel and saddle assembly.
- 5. Perform necessary load tests, inspections, operator training, etc. as prescribed in the ANSI/ASME B30.20 standard.



- 1. With Adjusto-Karrier standing on the floor with drum holder (saddle) in horizontal position, lower hoist and engage hoist hook into the lifting eye.
- 2. Raise hoist to lift Adjusto-Karrier clear of floor and move it to the drum.

Back off each adjusting screw using the removeable hand crank.

Position Adjusto-Karrier over drum.





- 5. Lower with hoist until drum holder is aligned with the center of the load.
- 6. Turn adjusting screw on each side of drum to tighten binder straps so drum is centered in drum holder.

- 7. Raise hoist and position drum at pouring station.
- 8. Pour drum by pulling on pull chain and rotating drum to suitable pouring angle.
- 9. After pouring is completed, use pull chain to rotate drum back to upright and lower hoist to return drum to floor.
- 10. Remove drum by backing out one adjusting screw and raising hoist to lift Adjusto-Karrier clear of drum.



Maintenance

Periodic inspection for the general condition of structural and mechanical components is imperative for safe and efficient operation.

- 1. Lubricate gear teeth and roller chain.
- 2. Clean and oil moving parts periodically. Clean and lubricate more often in environments where dust, dirt or other foreign particles will effect the performance of moving parts.
- 3. Periodically inspect all moving parts, framework, drum holder and contact areas for signs of wear, fatigue, or loosening. Tighten, adjust, or replace parts as necessary to prevent failure and maintain proper function.
- 4. Worn or damaged parts must be properly replaced with the correct, genuine Morse parts.
