
Every Morse drum handler is inspected prior to shipping. However, damage may be incurred during transit.

- Check for visible damage. If you choose to accept damaged freight, always sign noting the damage on the BILL OF LADING.
- Document the damage and have the truck driver sign. We recommend keeping a digital camera at your receiving dock for this purpose.
- Open packages expeditiously to check the condition of the goods.
 There is only a 24 hour window to notify the carrier of any concealed damage.
- IMMEDIATELY REPORT ALL DAMAGE TO THE SHIPPING COMPANY! Then you may contact Morse for assistance with your freight claim
- Morse Manufacturing will not be held responsible for any damaged freight that is not signed for as damaged.

Delivery to non-business addresses without a loading dock result in additional freight charges. Residential delivery fees, inside delivery fees, re-delivery charges, and lift gate services will be added by the truck line, and are non-negotiable.

Limited 2 Year Warranty

Morse drum handling equipment is guaranteed against defects in workmanship or materials for **TWO YEARS** when used properly within its rated capacity. Warranty does not cover wear from normal use or damage from accident or abuse. Motors and other purchased parts carry the warranties of their manufacturers.



For warranty claims, contact your Morse Dealer to obtain a return authorization number, and for return freight advice. Return freight must be prepaid.

In all instances, liability is limited to the purchase price paid or to repairing or replacing the product. Customer assumes liability for any modifications, unauthorized repairs or parts substitution.

Safety Information

Machine Description

Model 90S-HD Verti-Karrier™ is designed to lift and transport a standard 55-gallon (210 liter) steel drum 22.5" (57 cm) in diameter.

The maximum capacity is 2000 Lb. (907 kg).



Important

- 1. Review the Material Safety Data Sheet(s) for the material(s) in the drum(s) and take all necessary precautions. Safety shoes, work gloves, hard hat and other personal protective devices are recommended.
- Please read all instructions thoroughly before attempting to operate your new Morse drum handler.
- 3. Model 90S-HD Verti-Karrier™ has a maximum capacity rating of 2000 Lb. (907 kg) and is designed to lift and move a closed steel drum of the size and type noted above. DO NOT exceed this rating. Exceeding this rating or handling drums other than those mentioned above is unsafe and could result in equipment damage, excessive wear, awkward or dangerous handling.
- 4. When loading, unloading, operating, or maintaining your MORSE drum handler, always use care and good judgment. Maintain secure footing and a firm hold. Keep hands and loose clothing away from all moving parts. Never allow anyone to be below any part of a raised drum handler or drum. Read operating instructions and review the pictures in the sales brochure before operation.
- 5. Model 90S-HD is a "Group 1 structural and mechanical" below-the-hook lifting device which is covered by the American National Standard ASME B30.20. The user should comply with all aspects of this standard. Unit has been factory load tested and furnished with a load test certificate.

Operating Instructions

- 1. Start with Verti-Karrier™ on the floor resting on its gripping shoes.
- 2. Lower hoist hook to reach the lifting plate hole (item 4). Engage hoist hook to Verti-Karrier lift plate.
- 3. Raise hoist to lift Verti-Karrier™ off the floor. If gripping shoes do not stay in "open position," lower the Verti-Karrier™ and let the lift plate settle (push down if necessary) so that the peg on the latch weight passes down the ramp and settles under it. This puts the latch in position to hold the Verti-Karrier™ in the "open position." Raise hoist again to lift the "open" Verti-Karrier™.
- 4. Move hoist with "open" Verti-Karrier™ over the drum and lower it. Hoist should be guided so that Verti-Karrier settles across the center of the drum top. Latch will automatically change position which will allow the grippers to close and grip the drum when the hoist is raised.
- 5. The base (item 1) features three hole settings for making adjustments to the gripping shoe diameter. The lifter is factory set with the stop bolts (item 8) in the center hole location. If adjustments need to be made, move the stop bolts up for a slightly smaller diameter, or down for a slightly larger diameter. Keep bolts in same hole setting relative to each other.
- 6. Raise hoist to lift the drum. You may move the drum as necessary by moving the hoist.
- 7. To place the drum, simply lower the hoist. Continue to lower hoist so that lift plate settles to permit the latch to return to its "open position."
- 8. Raise the hoist to lift the Verti-Karrier™ clear of the drum. It should hold open to be ready to get the next drum as in step 4. If it does not stay open, lower the hoist and check that the latch weight peg is properly moving down the ramp and into its hold open position.

Maintenance

- Oil all joints where there are clevis pins. Oil latch weight as it must pivot freely.
- Lightly grease the inside edges of uprights so that the lifting plate (item 4) will slide freely. Lightly grease the latch pin and latch ramp to assure correct latch action.
- Periodically inspect all moving parts, framework and contact areas for signs of wear, fatigue or loosening. Tighten, adjust or replace parts as necessary to prevent failure and maintain proper function.
